ORDER – Eid-ul-Azha/Hide collection.

No: SO(Jud-I)HD/8-1(04)/2020-Corona (Cattle Mandi): On the occasion of Eid-ul-Azha, it is expedient to reiterate the code of conduct for collection of hides of sacrificial animals and accordingly following directions are issued:

- 1) Collection of hides without permission from the Commissioner / Deputy Commissioners is not allowed. It is to be ensured that policy guidelines and NACTA SOPs are strictly followed while granting such permissions.
- 2) The permission granted to those already holding permission for collection of hides on Eid-ul-Azha in 2019 shall be valid for Eid-ul-Azha in the year 2020.
- 3) Commissioner / Deputy Commissioner shall ensure that only registered charities / Madaris and Philanthropic Organizations are permitted and no banned organizations gets / retains permission or collects hides under garb of some other name.
- 4) Setting up of camps for collection of hides & use of banners for such purpose is banned.
- 5) Use of flags and loudspeaker(s) on vehicles and buildings for making announcements regarding collection of hides is prohibited.
- 6) Collection of hides by force as strictly prohibited and will not be tolerated.
- 7) Ban on carrying weapons shall be strictly implemented. (Licensed weapons all permission issued by Home Department to carry weapon is relaxation of ban u/s 144 Cr.P.C. will remain suspended during this period).
- 8) Those permitted collection and transporting the collected hides shall carry the permission and ID Card during such activities.
- 9) Those violating any condition shall have the hides confiscated which shall be donated / disposed off by Commissioner / Deputy Commissioner and given to reputed charitable organization(s).
- 10) Those applying afresh or carrying permission for year 2019 shall have to inform Deputy Commissioner in writing about its / their plan about their collection are and give undertaking duly signed by head of that organization / Head within such area that they shall abide by all the terms & conditions / code of conduct.
- 11) That Law Enforcement Agencies under orders / intimation from District Administration may conduct checking on spot for ensuring compliance.

Any person violating any of the conditions shall be prosecuted against under the relevant laws.
