ORDER (Shopping Malls)

No. SO(Jud-I)HD/8-1(04)/2020-Corona: Reference: the directions of the Hon'ble Supreme Court of Pakistan vide order dated 18th May, 2020 in Suo Moto Case No. 01/2020, and Home Department, Government of Sindh letter No. F.P./Corona-2019/Misc/2020 dated 18th May, 2020, addressed to National Health Services, Regulations & Coordination (NHSRC) and the subsequent response received from NHSRC vide letter No.1-2/2020 (Admin-I) dated 18th May, 2020. The Government of Sindh, based on directions of Hon'ble Court response of NHSRC and for uniformity with other provinces and in continuation and partial modification of order of even number 10th May, 2020 hereby declare that:

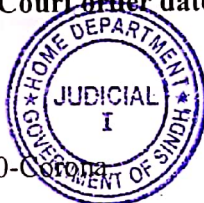
1. **Shopping Malls situated in the province of Sindh may open subject to the condition of strictly adhering to the Standard Operating Procedures (SOPs) issued by Home Department, Government of Sindh from time to time including:**
 - i) No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April, 2020 and
 - ii) No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs-Shops dated 10th May, 2020.

All the conditions and provisions including opening timings (08:00 am to 05:00 pm) shall remain the same as in the original order of even number dated 10th May, 2020.

This order shall not apply to following shops situated within Malls:

- Food Courts
- Beauty Parlors / Beauty Salons
- Entertainment / play areas

2. **Provision of para-2 of the order of even number dated 10th May, 2020 (regarding Fridays, Saturdays and Sundays as "safe days") shall remain suspended in view of the Hon'ble Supreme Court order dated 18th May, 2020 referred above.**
