No. SO(J-I)/HD/8-1(04)/2020-Corona/IEC-XVII. In pursuance of the Government of Sindh Notification bearing No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 and 08.04.2020, and Committee constituted vide Home Department, Government of Sindh Notification bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 28th April, 2020, the sub-committee-II examined the requests/applications received from the export-oriented industries in the light of Home Department Order No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14th April 2020, wherein such industries were allowed to operate subject to the condition of ensuring adherence to SOPs bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April 2020, issued by Home Department in view of COVID-19 measures.

2. Now, therefore, on the recommendations received from the Secretary, Labour & Human Resources Department / Chairman, Sub-Committee-II vide letter No. PS/SECY/LAB&HR/COVID-19/2020 dated 14th May 2020, the following export-oriented factories/manufacturing units, which are found fulfilling the criteria as per the Order and SOPs referred above {i.e. (i) Verification of export order by TDAP, (ii) Undertaking by CEO/owner on ensuring arrangements within their premises as per SOPs referred above for COVID - 19 prevention, and (iii) List of workers/staff/management who will be present/working in the premises of factory/manufacturing unit during its operation}. These units are permitted to start their operation (for export related items) subject to adherence to the SOPs.
