SUBJECT: - MINUTES OF PROCUREMENT COMMITTEE MEETING FOR PROCUREMENT OF HARDWARE (COMPUTER COMPONENT), PLANT & MACHINERY AND FURNITURE AND FIXTURE HELD ON 10-08-2022 AT 11.00 A.M. UNDER THE CHAIRMANSHIP OF ADDITIONAL SECRETARY (ADMN.), HOME DEPARTMENT, GOVERNMENT OF SINDH, KARACHI TO OPEN FINANCIAL PROPOSALS.

A Procurement Committee meeting was held on 10-08-2022 at 11.00 A.M. for Procurement of Hardware (Computer Component), Plant & Machinery and Furniture & Fixture under the Chairmanship of Additional Secretary (Admn.), Home Department, Government of Sindh, Karachi to open financial proposals of Tender documents submitted by Bidders / Firms.

3. The meeting started with the welcome remarks by the Chair. The Section Officer (Admn.)/Secretary of the Committee informed that following bidders participated and submitted proposals during the meeting held on 07-07-2022 where under technical proposals were opened in the presence of Committee Members and Bidders. He apprised that no bidder has submitted their proposals against the Item at Sr. No.1 i.e. **Photocopier** under component "**Plant & Machinery**". He further intimated that another Procurement Committee meeting was held on 28-07-2022 to examine / evaluate technical proposals submitted by the Bidders (Minutes of the meeting placed at **Annex-II**):

C. Procurement of Furniture & Fixture (Annex-V)

4. After scrutinizing of Technical Proposals, it was observed that M/s Kingsman Traders submitted proposals against all three components combined in single envelope. It was further noticed that the said firm did not submit proper, mandatory and the requisite documents as per prescribed criteria. Therefore, recommended to disqualify it against all components.

5. However, during the meeting on 10-08-2022 held under the Chairmanship of Additional Secretary (Admn.), Home Department, the Financial Proposals of the rest of bidders were opened in the presence of Committee Members and representative of the bidders.

6. After scrutiny of Technical and Financial Proposals in the light of Eligibility / Evaluation Criteria as well under SPPRA Rules, 2010 (as Amended), the Procurement Committee prepared Bid Evaluation Reports of each and every bidder and recommendations against all three components, placed at **Annex-VI, VII & VIII** respectively.


